



**CAMDEN PROPERTY TRUST ANNOUNCES
TAX CHARACTERISTICS OF 2014 DISTRIBUTIONS**

Houston, TEXAS (January 16, 2015) - Camden Property Trust (NYSE:CPT) announced today the income tax characteristics of its 2014 distributions paid to shareholders as they will be reported on Form 1099-DIV. The Company is releasing information at this time to aid banks, brokerage firms, and institutional investors that are required to issue Form 1099s to their account holders. For corporate shareholders the Section 291(a) preference item is 2.9164% of the total distribution.
